Dear Parent

Thank you for your interest in your child starting Oldfield Pre-school. Children are eligible to start at Oldfield Pre-school in the term in which their 3rd birthday occurs (provided a place is available). Please complete and return the Register of Interest form, so that we can send you an Application Form at the relevant time.

We send parents of those children who have registered with us (by returning the Register of Interest form) an Application Form in late January / early February of the academic (school) year before your child is be eligible to start at Oldfield Pre-School. The Application Form is the formal application for sessions at Oldfield Pre-School, and enables you to apply for specific sessions, starting in the following September, January or April.

Application forms must be returned by the closing date stated on the form - usually the second Wednesday of March, to ensure your child is included in the allocation of sessions for the following Pre-School academic year (whether starting in September, January or April). We will inform you whether or not your application has been successful and of your allocation of sessions by 31st May in the academic year before your child is due to start.

Applications received after the closing date are put on the waiting list and processed if we have space.

We offer

- Whole day sessions which run from 8.30 – 3.30 p.m.
- Morning sessions which run from 8.45 a.m. till 11.45 a.m.
- Afternoon sessions which run from 12.30 p.m. till 3.30 p.m.
- Lunch clubs which take place between 11.45 a.m. and 12.30 p.m (and must be attached to a morning or afternoon session)

Sessions not covered by government funding are charged at the hourly rate, which will be confirmed to you with your offer of a place. Our fees are reviewed annually. For information about our current fees see <https://www.oldfieldpreschool.org/sessions-and-fees>.

To find out more about your eligibility for government funding and assistance with paying for childcare (e.g. tax free childcare and tax credits for childcare) please see <https://www.childcarechoices.gov.uk/>

- Eligible working families of 2 year olds are able to claim up to 15 hours per week of government funding.
- Some 2 year olds (where income is below a specific level and the family is in receipt of certain benefits) are able to claim up to 15 hours per week of government funding. Eligibility to claim this government funding is usually confirmed by a local Children Centre.
- All children who have turned at least 3 years old by 31st August, 31st December, 31st March are able to claim up to 15 hours per week government funding the following term. e.g. child turns 3 by 31st August, can claim from September.
- Eligible working families of 3 and 4 year olds are able to claim up to 15 additional hours per week government funding (to make a maximum of 30 hours).

We look forward to receiving your completed register of interest form.
